With its combination of scale, efficiency and commitment to sustainability, Côte d'Ivoire is more than a high-quality supplier. The country is a trusted partner for buyers, investors, and stakeholders, shaping the future of the cashew market.

Gateway to Global Cashew Trade

Côte d'Ivoire offers buyers a fully integrated cashew value chain, ensuring efficiency and reliability from production to processing and export.

Powering Local Transformation


With over 30 modern processing plants in operation, Côte d'Ivoire is expanding its capacity and drives value addition at origin.

Driving Innovation & Sustainability

Backed by strong public-private commitment, Côte d'Ivoire is a leading country in sustainable certified production (organic, fairtrade), traceability and digital solutions, building a cashew sector that is competitive, transparent, and future-proof.

Facts and Figures

- In 2025, Côte d'Ivoire produced 1.5 million metric tons (MT) of cashews, representing 27% of the global raw nut supply.
- The cashew local processing has grown sixfold over the past eleven years, establishing Côte d'Ivoire as the world's 3rd largest cashew processor, after Vietnam and India (2024).
- The country has set an ambitious target to process 50% of its raw cashew nuts locally by 2030, equivalent to 185,000 - 200,000 MT of kernels. It is estimated that 135,000 MT of kernels will already be processed by 2025.
- Local processing already provides 15,000 direct jobs, with women holding 70% of these positions.



Enabling Policies - Driving Success

Visionary policies and reforms that combine sustainability with competitiveness have been launched by the Cotton and Cashew Council (CCA):

- Sustainability and Biodiversity Preservation Strategy to restore degraded forest landscapes while improving the resilience of agricultural systems.
- Taxing raw nut exports to stimulate processing.
- Government support for industrial investment.
- Tax incentives and technical support for processors.
- Three agro-industrial zones dedicated to cashew processing built in Korhogo, Bondoukou and Séguéla.



Sustainable Nut Initiative (SNI)

A pre-competitive platform bringing together private-sector stakeholders in the nut supply chain, SNI works towards a sustainable nut sector through and beyond certification and risk-based approaches.



African Cashew Alliance (ACA)

ACA is a supra-national platform that brings together African and international companies to promote a competitive African cashew industry through technical assistance, investment facilitation, standardization and the sharing of best practices.



Cotton and Cashew Council (CCA)

The CCA is a regulatory and development body for the cotton, cashew nut and shea sectors in Côte d'Ivoire, aiming to optimize producers' incomes, regulate the market, and support local processing.



Market-Oriented Value Chains for Jobs and Growth in the ECOWAS Region (GIZ/MOVE- ComCashew)
